

From The Executive Officer

On 19 September 2018, ATSA's name was formally changed to Assistive Technology Suppliers Australia. This change was endorsed back in May with the adoption of the new constitution.

ATSA is now a registered company limited by guarantee under the Australian Securities and Investments Commission (ASIC). Following this change, we have replaced our committee with a Board of Management. The changes will fully be implemented following our next AGM in Melbourne on 22 November 2018.

It is great to see members registering their services on the new ATSA website, and I encourage those who have not already done so to log on to our site and register your services. ATSA will soon run a promotion campaign to promote ATSA Code of Practice members to the public.

The NDIA is working with various regulatory bodies to help provide safe structures for buyers and users of AT, and this includes ATSA. This is why we are looking at implementing an industry self-regulation model, the details of which have been included in this newsletter. Please let me know if you have any questions.

I must say I am blown away by the response to the ATSA Independent Living Expos for 2019. With well over 80 per cent of stands already sold, it is shaping up to be another successful year for the expos. You should have all received the Call for Papers for the expo's education program. Click here to submit a presentation.

Unfortunately, I must again remind everyone of the email scams offering details of attendees from the expos. Please delete and do not respond to these emails. Neither ATSA nor Interpoint sell this information, so treat with great caution any persons offering such information.

The Senate inquiry "The need for regulation of mobility scooters, also known as motorised wheelchairs" has been released with its principle recommendation of a nationally consistent regulatory framework that must be evidence-based. ATSA will continue to work with AustRoads and National Transport Commission in this matter. It is important to note, the current legislation has not been changed.

Changes to the Australian Register of Therapeutic Goods (ARTG) listing has come to the attention of ATSA, with charges of \$530 to be applied to listing of Class 1 medical device on the ARTG. ATSA has taken up this matter with the TGA and will keep members informed as information becomes available. However, in the interim it is wise to ensure you minimise the potential impact on your business. Refer to www.tga.gov.au for guidance.

Vale: Ray Saad A Great Loss to Our Industry

Half a lifetime ago I was very involved with wheelchair sports and had the honour of playing in the Australian men's wheelchair basketball team for some six years. It was around this time I was introduced to an incredibly impressive young man in Raymond Saad. With great sadness, I was part of a large group of mourners who recently came together in Sydney to celebrate Ray's life and pay our respects.

Ray was one of those all too rare people with great generosity of spirit, a man who could lift a room just with his presence and had a real knack for bringing people together. His handshake told you a lot about him – strong, direct and resilient; and he was blessed with a wicked sense of humour.

Ray was the definitive example of someone born to work and work very hard he did. He had run his own business before and in 2005 Ray took over the successful Sydney based business known simply as Wheelchair Sales. Wheelchair Sales had been established by an old basketball team mate of mine, fellow Australian player Errol Hyde and his wife Sonja.

Errol remembers Ray as a highly competitive tennis player, "easily recognised by his signature terry toweling head-band".

"He'd had a Mini Moke at one stage, he loved it, and told the story of coming back to it to find a homeless guy asleep in the back!" Errol recalled.

In his days as managing director of Seating Dynamics, Permobil's Mal Turnbull had dealt with Ray for more than a decade.

"Most of my contact with Ray was through business. I always felt better for spending time with him. Ray was always very sharp in terms of product – what was good, where it fitted in his product line and in the market," Mal noted.

"One memory I have is being with Ray at the Prince of Wales spinal injuries unit. We were with some therapists and a few newly injured users. One of them needed a replacement front castor for his chair and he asked Ray where he would get it. Ray answered: 'Mate, I could sell you one. But if you get online and go to SportAid you'll pay a whole lot less'.



"It has always stuck in my mind as an example of someone who was far more interested in doing the right thing by the customer than just nailing a quick sale. It was typical of how Ray did business and his honest care for people. In all my years in the industry I have never heard anyone say a bad word about Ray."

Ray had some severe health battles over the past few years but his resilience and commitment to his business and customers never waned

Errol explained: "His sister Monica has been tremendous, working beside him for the last 12 months, very talented, working in the office and implementing many ideas he and she had. Whilst his brother John will now come aboard as manager. Otherwise it will be business as usual."

I almost forgot to mention one facet of Ray's life. He was a wheelchair user as a result of a car accident when just three years old. However, Ray's personality, drive and enormous energy always stood out miles ahead of his disability. He will be sorely missed by all who knew him.



Consultation on a Proposed ATSA Certification/Accreditation Scheme

ATSA Members are currently being consulted on the development of a proposed Certification/Accreditation Scheme - Objective 1.2 of the ATSA Strategic Plan, i.e. "A recognised accreditation system and standards for the AT industry".

If you missed out on the consultation email which was sent out in September, please let David Sinclair (david.sinclair@ATSA. org.au) know, and we will provide you with the outline of the scheme. There is still time to have your two cent's worth and all comments and ideas are welcome.

The first part of this project is to undertake some preparatory work involving consultation with you and government bodies such as the NDIA. In addition, a review of the current ATSA Code of Practice to identify what might need tweaking to embed the Code in a more formalized, low cost accreditation/certification scheme, modelled on the British Healthcare Trades Association Code and Audit scheme in the UK.

The objectives of this project are to propose a scheme which:

- Maintains industry self-regulation and consumer choice in AT service and product purchase, while at the same time providing guidance for selection of high quality and safe AT
- Maintains trust in the AT product and service sector
- Lifts the status of the ATSA Code of Practice as a recognised voluntary industry code of practice

- Strengthens ATSA's position as the peak body for AT in Australia by recognition of ATSA members as preferred ethical suppliers
- Improves the professionalism and skillset of the AT industry workforce
- Avoids costly government regulation of the AT industry in response to real or perceived problems in the supply of AT products and services

In the coming weeks we will be discussing our ideas with government, to seek their input with no commitments. We intend to start discussions with the NDIA, State disability schemes and the Australian Competition and Consumer Commission.

This is just the beginning, and it will take time before we are ready to implement. There will be several steps and sign offs by the Committee. This stage is anticipated not to be completed before the end of 2018.

Get To Know A Member

Tiffany Heddes - Director, Special Needs Solutions

Tiffany fell into the AT industry after her second son Bailey was born with a rare form of muscular dystrophy. After struggling to source any equipment in Australia to support his needs, Tiffany began importing products, such as supportive seating systems, from the UK.

Realising that she was not alone, and that other families required the same equipment, Tiffany began sourcing equipment for others and thus, Special Needs Solutions was born.

Thirteen years on, the distributor of paediatric equipment has nine staff members and services the Queensland and northern NSW area.

Tiffany, who has been a member of ATSA for five years, believes professional businesses in any industry should be linked with their professional body.

"I joined because ATSA is our governing body, and as we are a professional business, we want to be associated with ATSA and its guidelines for AT suppliers," she said.

"ATSA offers members tremendous support and provides the opportunity to meet with others in our industry at ATSA events, and of course the ATSA Independent Living Expos. Exhibiting at those expos is very important to us."

Tiffany is also an active volunteer for Variety – a national children's charity that supports children and families facing challenges through sickness, disadvantage or living with special needs.

Every year, the charity runs the 'Variety Bash', Australia's largest and longest running charity motoring event. The Variety Bash is a fundraising event where participants drive cars that are at least 30 years old to remote and regional parts of Australia, visiting local towns, stopping into schools and organisations to visit kids.

"This year we raised \$17,000 and overall the Bash raised \$1.3 million," said Tiffany. "I am very passionate about assisting Variety and encourage other ATSA Members to be involved with the charity".

"When Bailey was born, it was a real struggle because there was no help and no hope. Through Special Needs Solutions and Variety I can give families [who are going through the same thing I went through] the help and hope they need by providing funds and equipment that makes their lives easier."





Home Modifications Now Available Through EnableNSW

EnableNSW has partnered with the NSW Ministry of Health to implement a new state-wide home modifications funding program as part of the Safe and Supported at Home SaSH) initiative.

The aim of the program is to assist people where discharge from hospital or potential readmission is impacted by an ability to access home modifications.

Funding may be available for minor home modifications or emporary solutions - such as grab rails, ramps to access the home, doorway widening, shower hob reduction and portable/modular facilities. Major home modifications may also be considered in some circumstances, such as wheelchair accessible bathroom modifications.

EnableNSW Future Focus on Health Support, Integration With Local Equipment Pools

EnableNSW hosted an industry forum at Rosehill Gardens during September for equipment prescribers and suppliers, presenting an overview of its current and future vision for aids and equipment across NSW Health.

"This meeting provided the opportunity to confirm our renewed focus on health support and present future work including greater integration with local NSW Health equipment loan pools," said EnableNSW manager Jackie Hiller. "We were thrilled that an overwhelming 83 per cent of attendees agreed that we have the right vision for the future."

Key presentations included:

- Our Vision In A New Environment Covering guiding principles to meet health related AT needs for people in NSW, and the introduction of a major new initiative - working with Local Health Districts to achieve faster hospital discharge and cover gaps between short and long term equipment provision.
- Working Together: EnableNSW and Local Equipment Pools - Further details about work underway to help streamline access to Local Health District short term loan pools, to facilitate faster hospital discharge for people who need equipment and to help fill the gaps between current short and long term equipment options.
- Smarter and sustainable procurement in action An overview
 of the effective use of contracts to purchase and provide
 aids and equipment, use of and access to the purpose-built
 EnableNSW Equipment Centre, savings and benefits to the
 community (for example, reduced wait times) and upcoming
 procurement initiatives.
- Assistive Technology and Home Modifications under the NDIS - Dr Lloyd Walker, Director of Assistive Technology for the National Disability Insurance Agency (NDIA) provided an overview of a new approach for assessing Assistive Technology needs, soon to be tested.

More to Universal Design Than Access

This year's Australian Universal Design Conference took place at the Brisbane Convention and Exhibition Centre on 4-5 September. Under the theme of Home & Away, the conference explored the concepts of creating accessible built environments and inclusive tourism and travel opportunities for all.

According to keynote speaker Chris Veitch, a specialist in tourism management, accessible tourism is one of the most exciting parts of tourism development because it leads to many opportunities.

Hobsons Bay City Council's access and inclusion officer Tom Bevan also spoke about the council's Accessible Beaches Project and how it continues to push the boundaries when it comes to a complex natural environment.

In a first for Australia, beach matting is now available 24/7, and beach wheelchairs, including water chairs are also available at Altona and Williamstown beaches for the 16,000 residents who live with disability. The infrastructure also provides access for older people and those with prams and toddlers. As well as special matting imported from France, there is a changing places facility which features a hoist for transfers, an online booking system and an accessibility upgrade to the surrounding urban area.

Changes to NDIA Registration

Providers have always been required to be registered in the State that they deliver a service.

New registration processes are now in effect, since 1 July, 2018, in NSW and SA, in line with the establishment of NDIS Quality and Safeguards commission.

NDIS Quality and Safeguards Commission begins

The NDIS Quality and Safeguards Commission (NDIS Commission) now registers and regulates providers in New South Wales and South Australia. Existing approved provider registration details have been transferred to the NDIS Commission. If you had pending registration groups that were not approved by the NDIA before 1 July, you will need to begin a new application for those registration groups with the NDIS Commission.

The NQSC presented new processes at NDIA National Provider Forums in February and March this year and have been consulting widely in NSW and SA.

TGA Update

From 1 July 2018 the application fee of \$530 for inclusion of a Class I medical device in the ARTG with an annual renewal fee of \$90 now applies. ATSA made representation of the concern of the industry of the major change. Unfortunately to date there has been no movement in these new fees however ATSA has been informed that the new fees will be review in the coming months.

The TGA has informed ATSA that same fee was applied to export only medical devices. While export only medical devices are included in the ARTG as Class I medical devices, the TGA principality focusses on verifying the correctness of the more limited information provided by the sponsor for such products. This differs from the information provided for other Class I medical devices where the focus is on assessing the product for their safety and performance. An opportunity has also been identified to further streamline the processing of applications for export only medical devices by modifying existing software to automatically include such devices in the ARTG. The automation will mean that sponsors will now take full responsibility for the correctness of the information included in an application.

Reflecting the automation of the approval process but allowing for the cost of maintaining the software, and consistent with the Australian Cost Recovery Guidelines, a lower application fee of \$90 will now apply to include a kind of medical device that is for export only on the ARTG. Some sponsors of affected products may have already paid the \$530 fee for the inclusion of their export only medical devices. This amounts to a payment of \$440 more than is required under the new export only fee. The TGA will soon make arrangements to refund the excess amounts paid by these sponsors.

In addition, ATSA has been invited to work with the TGA in the review of what should be listed on the ARTG, class 1 medical devices. This work has just commenced and ATSA recommends that before you either list or close a listing to contact the TGA. Timely Warning From ACCC: Small Businesses Need Fairer Contracts, Stronger Codes

Unfair contract terms, misleading conduct and scams are some of the biggest issues affecting small businesses in Australia, according to the ACCC's latest Small Business in Focus report. The issue most commonly reported remains misleading or deceptive conduct, closely followed by enquiries about consumer guarantees.

Unfair contracts remain a major issue, and in the past six months the ACCC has taken action against businesses including ATM provider Cardtronics, potato wholesaler, Mitolo, Wisdom Properties Group and AWB Harvest Finance Pools over potentially unfair contract terms.
