Record numbers attended the ATSA Independent Living Expo's in May

Despite COVID and a number of date changes the ATSA Independent Living Expo's in Melbourne and Perth triumphed.

The first event was held in Melbourne and the sold-out two-day expo was the largest assistive technology event to be held anywhere in the world this year (to date), attracting 3000 visitors and 160 exhibitors on May 18-19. Shadow Minister for the NDIS, Bill Shorten, was a guest speaker on day two and he spoke about strengthening the AT sector by encouraging a domestic industry with more manufacturing and investment.

ATSA presented a number of awards at the popular ATSA member and exhibitor networking function at the end of day one: Amy Bjornson, from Sunrise Medical was awarded the Most Registered and Attended Session Presenter, TabTimer was awarded the Best Exhibitor Marketing Campaign, Best Small Stand was awarded to Independence Automotive and Best Large Stand winner was Invacare Australia & New Zealand.

The week following Melbourne, doors opened to the second ATSA Independent Living Expo to be held in Perth, where there was also a record number of exhibitors and attendees. Disappointingly, the recent COVID outbreak in Victoria meant that day two ended early. Everyone's support and understanding has been amazing.

Before the end of day one ATSA hosted the networking drinks in Perth where awards were presented. The award winners were: Pearl Chan and Unicare Health for the Best Marketing Campaign, and Bas Jansen was presented the award for Most Pre-registered and Best Attended Education Session. Wonder Sheet/Neeki Designs was winner of Best Small Stand and Para Mobility won Best Large stand.

"ATSA's Independent Living Expos play a huge role for suppliers to reach therapists, allied health professionals and the wider disability community. Nowhere was this more evident than the recent shows in Melbourne and Perth where record numbers attended. In spite of cancellations from last year and caution surrounding covid, both shows were sold out and in total more than 5000 people visited the events," said Simon Cooper, Managing Director, Interpoint Events.

Thank you to all our ATSA members, exhibitors, presenters, attendees, Interpoint Events and everyone who helped make ATSA Independent Living Expo's such a success.

NDIS Commission website redevelopment - seeking NDIS providers and NDIS workers

The NDIS Quality and Safeguards Commission (NDIS Commission) is redeveloping their website this year to make it more user-focused, intuitive and easy to navigate.

They are working with stakeholders to obtain feedback about the <u>current website</u> and to understand how it can be improved, and are inviting **expressions of interest from NDIS providers and NDIS workers** who would like to be involved in the following activities this month:

- Activity 1: 30-minute interview: The purpose of the interview is to understand the NDIS providers' and NDIS workers' experiences with the NDIS Commission in general, and your views on the website in particular (e.g. what is working well, ways it can be improved, etc.). The interview will be conducted by video call at a mutually agreed time in early June.
- Activity 2: Online activities (approx. 20 minutes):
 These activities will involve doing a card sort (organising topics and tasks into categories) and doing some task testing (seeing where you would go on the website to complete a task). The results of these exercises will help inform the new website information architecture. They will take around 20 minutes each and can be done on any computer at a time convenient to you. (Note that the card sort activity is not WCAG compliant.)

The TGA is consulting on potential refinements to the new regulatory framework for personalised medical devices

Regulatory changes introducing a new framework for the regulation of personalised medical devices commenced on 25 February 2021, including a transition period for eligible manufacturers and sponsors until 1 November 2024. Comprehensive information about the new framework is available via the personalised medical devices landing page on the TGA website.

During the implementation phase a number of sectors have raised concerns over the impact of the new framework including comments that:

- the new regulatory requirements are a duplication of existing regulation already provided by professional accrediting bodies or other regulatory bodies;
- the classification of certain requirements for some devices were excessive compared with the actual risk posed by the device; and/or
- the regulatory burden associated with compliance is unreasonable.

The TGA are now seeking feedback through a public consultation process on potential options for refining the framework that will ensure risks associated with the production and supply of personalised medical devices are appropriately mitigated, without imposing unnecessary administrative and regulatory burden.

We encourage you to provide your feedback on the proposed options for refining the framework. You can do this via ATSA your feedback by COB 25 June. If you wish to submit directly to the TGA, **The consultation closes 11:59pm 14 July 2021**. Preliminary insights from Motorised Mobility Devices research – University of Wollongong and ATSA

The year 1981 was proclaimed the International Year of Disabled Persons by the United Nations. It called for a plan of action with an emphasis on equalization of opportunities, rehabilitation and prevention of disabilities. It is now 40 years since Australia took part and based on the some of the preliminary findings, we are still a long way from inclusion and addressing some of the most basic needs for users of MMDs to get around.

To date, the University of Wollongong has interviewed 50 people using wheelchairs or scooters.

The initial common themes from respondents coming through is.

- The lack of infrastructure continues to create difficulties for respondents to participate in everyday activities these include broken footpaths, cars parked across footpaths, steep gradients, no ramps. This in some cases, forcing MMD users to take risks such as using the road as a passage to get around.
- Evidence is emerging that due to the approach to design spaces for standing and walking bodies this attitude is contributing to real emotional – fear, frustration, anxiety, embarrassment, and shame as people encountered situations that caused interruptions to their journeys. These emotional intensities may accumulate over time and work to prevent people from living the lives they want to live.
- Mobility is inherently related to independence and positive emotions such as happiness, love and joy at being able to move freely. This is reinforcing the importance of social and material infrastructures that can support the free flow of sitting and wheeling bodies.
